AFFIDAVIT AND APPLICATION FOR ARREST WARRANT

The Undersigned Affiant, who after being duly sworn by me, on oath, makes the following statement:
I have reason to believe and do believe that: Caylon Goins , DOB: 03/16/2002 did then and there, on or about 10-01-2020 at 12118 Walnut Park Xing commit the offense of:

Murder-- (1st Degree Felony)

On October 1, 2020 at about 4:35 P.M. Austin 9-1-1 received a call of a shooting in the parking lot of 12118 Walnut Park Xing, Limestone Canyon Apartments. Officer Gabriella Fekette # 8898 arrived and found a black male, later identified as Dontato Ward, sitting inside a 2010 Silver Ford Focus bearing Texas temporary license plate 86965W7, near building number 4 with a possible gunshot wound to his head. The silver Ford Focus was crashed into a detached garage in the parking lot of the complex.

Several minutes later Officers located another victim, later identified as Keivonta Coleman, in the same apartment Austin Police Department Report Number #20-2750965 complex with a possible gunshot wound to his right shoulder.

Ward and Coleman were both transported to Dell Seton Medical Center. Ward was pronounced deceased on October 2, 2020, at 7:21 A.M. by Dr Jessica Efrid.

Your affiant responded to Dell Seton Medical Center to interview Coleman. Coleman said his cousin, Donato Ward, picked him up in the silver vehicle at about 1:00 that afternoon. He added they drove around for a few hours then went to pick up their friend 'Scully' at 12118 Walnut Park Xing. Coleman told your affiant the vehicle they were in belonged to "Scully". Coleman said "Scully" would text them that he was in one apartment then send a text that he was in another apartment soon after.

Coleman said they felt like "Scully" might be setting them up for something. Ward backed the vehicle into a parking spot near building number 4. Soon after parking the vehicle, Coleman said a white sedan with aftermarket rims pulled in front of their vehicle to block them in. The driver of the vehicle got out of the car. Coleman said he looked away but heard gunfire. Coleman said he got out of the vehicle and ran for safety.

Officer Christopher Chandler checked the license plate through the Department of Public Safety and found the 2010 Silver Ford Focus crashed into the garage was registered to Sylvester Omo Idehen Jr. Officer Chandler found a Texas Driver's License Photograph for Sylvester Idehen, a black male, born on January 20, 2001.

Your affiant showed the Driver's License photograph to Coleman and he said Idehen was the person he knew as "Scully".

APD Homicide Detective Nathan Sexton #5670 responded to the scene. Detective Sexton told me that it appeared that Ward had been in the driver's seat in the vehicle when he was struck by the projectile. Detective Sexton said

the vehicle crashed into a detached garage. When Officer arrived they found an AR-15 style shot gun inside the crashed vehicle. Detective Sexton also located three 9 mm fired cartridges near the same vehicle.

On October 1, 2020, a few hours after the murder, Idehen called the APD Homicide Office from phone number (512) 545-8411. Idehen said he was in College Station, Texas babysitting a relative and he could not meet with detectives. When asked about his vehicle, Idehen said Ward and Coleman took his vehicle without permission and left him stranded in a parking lot at about 4 P.M.

Idehen agreed to meet with Detectives at the APD Homicide office at 10 A.M. on October 2, 2020. Idehen did not show up for the meeting on October 2, 2020, and would not answer the phone when your affiant called.

On October 2, 2020 at about 4:30 P.M., your affiant met with Coleman at the APD Homicide Office. Coleman said that he was riding around in Idehen's vehicle with Ward when Idehen came up with a plan to steal a gun from someone that was selling the gun on Snapchat. Idehen came up with a plan to meet with the seller, take the gun and run back to the vehicle with Ward and Coleman, then they would leave without paying.

Idehen and the seller agreed to meet in the parking lot at Spare Time Texas, located near the intersection of East Pflugerville Parkway and Dessau Road. Coleman said the seller arrived in a white sedan with aftermarket rims. Idehen went to the sellers vehicle and brought the AR style shotgun back to his vehicle. Coleman said Idehen told him they had two more guns in the car and he wanted to try and get those too.

Coleman said the driver briefly walked to the vehicle he was in but he did not get a good look at him. Coleman said he only saw one person in the vehicle.

Idehen went back to the sellers vehicle. Coleman and Ward waited for Idehen to come back. Coleman said they waited for what seemed to be about 40 minutes. Coleman said they saw a Police vehicle drive through the area. Coleman said he and Ward began to get uncomfortable and left the parking lot leaving Idehen with the seller.

Coleman said they went to an apartment complex where Wards girlfriend lived and backed into a parking spot. Soon after a white vehicle with rims pulled up and blocked them in. Coleman said he saw the driver exit the vehicle with a gun in his hand. The man raised the gun and Coleman told Ward he was going to shoot. Coleman looked away and heard gunshots. Coleman said he looked up and saw his cousin had been shot but there was nothing he could do to help him. Coleman said he also knew he was shot but he took off running.

Coleman provided your affiant with the password to his cell phone and gave me consent to look at his text messages. Your affiant saw text message communication about the firearm sale between him and the number (512) 545-8411. Coleman told me this is the number he used to communicate with Idehen.

On October 4, 2020, your affiant had a phone interview with Idehen and his father, Sylvester Omo Idehen. Your affiant called the number (512) 545-8411 to speak with Idehen. Idehen said that he made contact with a person over Snapchat to purchase an AR style shotgun. Idehen said he uses the snapchat "vestup20".

Idehen said he never met the seller before and the seller sent him a text message with the meet location from a phone number with a 979 area code. Idehen said he already deleted the text message and he did not have the phone number anymore.

Idehen stated, he, Coleman and Ward arrived at the arranged meet location. Idehen said he exited the vehicle and walked up to the seller's vehicle and paid him for the shotgun. He took the firearm out of the seller's vehicle and

took it to the vehicle with Coleman and Ward. Idehen said he walked back to the seller's vehicle and he saw his vehicle drive away. The seller then drove away to follow Coleman and Ward.

Idehen said the seller blocked him on Snapchat so he could not see the username on the account.

Your affiant used a trusted law enforcement application and found the number (512) 545-8411 is associated with Sylvester Idehen and serviced by T-Mobile.

On October 6, 2020, your affiant presented a search warrant for call detail records for the phone number (512) 545- 8411 to District Court Judge P. David Wahlberg. Judge Wahlberg approved the search warrant and it was served to T-Mobile on the same day.

Your affiant received the T-Mobile records on October 12, 2020, and saw there were several calls made from (512) 545-8411 to the number (318) 344-9942 on the day of the murder. All of these calls were made prior to Idehen, Coleman and Ward meeting with the firearms dealer.

The records for the phone number (512) 545-8411 were between July 5, 2020 and October 5, 2020. Your affiant searched the records and found that October 1, 2020 was the only time the number (512) 545-8411 called the phone number (318) 344-9942.

The final call made to (318) 344-9942 was at about 3:18 P.M. near the parking lot of the Spare Time, where they met the firearms dealer.

Your affiant used a trusted law enforcement application and found the number to be associated with Caylon Goins, a black male born on March 16, 2002.

On September 21, 2019, Williamson County Sheriff's Office D. Griffin conducted a traffic stop near the 400 block of Limmer Loop in Round Rock, Williamson County, Texas. Your affiant obtained a copy of the electronic citation.

During the stop Goins told officers his phone number was (318) 344-9942. Goins told officers he lived at 5691 Corsica Loop in Round Rock, Texas. APD Officer Christopher Chandler #6763 went to the address and located a silver 2018 Ford Fusion bearing Texas License plate NBL-2952 parked in the garage at the 5691 Corsica Loop.

APD Crime Analyst Pam Mazak analyzed the location data provided by T-Mobile. The location data showed Idehen arriving in the area of the Spare time around 3:21 P.M. Idehen appeared to be in the parking lot until about 3:46 P.M. At about 3:46 P.M. Idehen travels south toward 12118 Walnut Park Xing.

Idehen's phone records show him to be in the area of 12118 Walnut Park Xing at about 4:30 P.M. the 9-1-1 call came in at about 4:35 P.M. Idehen's phone records appeared to show him leaving the area where the shooting occurred at about 4:41 P.M.

Your affiant viewed surveillance video taken from 12118 Walnut Park Xing, the apartment complex where the murder occurred. Around the time of the murder a light colored four door sedan enters the complex. Soon after entering the complex the vehicle leaves the complex. Your affiant compared this vehicle to the silver 2018 Ford Fusion parked in the garage at the address Goins provided during the traffic stop. This vehicle appears to have the same sun roof, body style, rims and antenna as the vehicle seen leaving the complex around the time of the murder.

On October 13, 2020, your affiant presented a search warrant for call detail records for the phone number (316) 344-9942 to District Court Judge Karen Sage. Judge Sage approved the search warrant and it was served to T-Mobile on the same day.

Your affiant received the T-Mobile records on October 21, 2020. Crime Analyst Pam Mazak analyzed the records. Goins phone appears to be in the vicinity of his home located at 5691 Corsica Loop, in Round Rock, Texas. Goins appears to be traveling toward Spare Time by about 2:40 P.M.

Goins and Idehen appear to be together in the vicinity of the Spare Time between 3:20 P.M. and 3:44 P.M.

Goins does not have any location data until about 5:03 P.M. when he and Idehen both appear to still be together in North Austin. At about 6:43 P.M Idehen and Goins appear to be traveling together on Highway 21 and eventually at about 8:11 P.M. they both appear to be in College Station, Texas near an address associated with Idehen's family.

Your affiant believes after Idehen took the shotgun from Goins and brought it back to his vehicle where Ward and Coleman were waiting. Ward and Coleman eventually left the parking lot of the Spare Time in Idehen's vehicle.

Soon after Idehen and Goins left the parking lot in Goins vehicle. Coleman gave Idehen their location and Idehen led Goins directly to them.

A light colored Ford Fusion that appears to match Goins' silver 2018 Ford Fusion is seen on apartment complex surveillance video entering the complex prior to the murder. The vehicle was in the complex for less than 2 minutes then exits. Several minutes later emergency vehicle are seen entering the complex responding to the 9-1-1 calls.

Your affiant believes after Goins found Idehens vehicle Goins attempted to block Idehen's vehicle from leaving so that he could retrieve his gun and Idehen could get his car back. Goins exited the driver's seat of his vehicle and fired three shots into the passenger side of Idehen's vehicle striking Coleman once in the shoulder and striking Ward in the head, causing Wards death.
